WHY CHANGE IN NAME

As per IS 4984: 2016

As polyethylene pipes are designed by their minimum required strength (MRS) the earlier nomenclature of high density polyethylene pipes has been re- named as polyethylene pipes and accordingly, the title of the standard has also been modified.

Material As per IS 4984: 2016, Page no- 4

5.1 General

The material used for the manufacture of pipes should not constitute toxic hazard, should not support microbial growth and should not give rise to unpleasant taste or odour, cloudiness or discoloration of water. Pipe manufacturers shall obtain a certificate of this effect from the manufacturer of raw material.






